REVOCATION AND DETERMINATION OF FEES

EXPLANATORY STATEMENT

INSTRUMENT NO. 97 OF 1999

This determination made under section 80 of the Energy and Water Act 1988 (the Act) revokes the existing Determination of Fees and sets fees for the purposes of the Act.

The determination is a disallowable instrument for the purpose of section 10 of the *Subordinate Laws Act 1989*.

The determination changes the basis for fees after commencement of the Canberra Sewerage and Water Supply Regulations (Amendment) 1999 (the amending Regulations).

Under the amending Regulations, the Government no longer approves plumbing or drainage plans and plumbing and drainers' permits are replaced by notification of the commencement of work. Regulation 36 of the amending Regulations provides for applications lodged before they commenced to continue to be dealt with under the old form of the Regulations. Older scales of fees continue to be determined in relation to changes in applications for plumbing or drainage work accepted before these dates. This includes applications made before 4 January 1999 when the majority of plumbing and drainage applicaions paid fees determined under the Building Act. The amounts payable by plumbers and drainers are not affected by this change.
