## APPOINTMENT OF MEMBERS TO TREATMENT ASSESSMENT PANELS

### **INSTRUMENT NO. 32 OF 1999**

#### **EXPLANATORY STATEMENT**

Each Treatment Assessment Panel comprises two experienced treatment workers and one legal practitioner. Section 130 of the *Drugs of Dependence Act 1989* (the Act) details the requirement as follows:

(1) The Minister shall, in writing, establish such treatment assessment panels as are necessary for the purposes of this Part.

(2) A panel shall consist of-

(a) a legal practitioner; and

(b) 2 other persons, each of whom has, in the opinion of the Minister, extensive knowledge of-

(i) the physical, psychological and social problems connected with the abuse of drugs of dependence or prohibited substances;

(ii) the treatment of persons suffering from such problems; or

(iii) health education in relation to such problems.

Section 131 of the Act details that:

(1) The Minister may, in writing signed by the Minister, appoint persons to be members of panels.

(2) A person shall be appointed as a part-time member.

(3) The Minister shall not appoint as a member a person who-

(a) has been convicted in Australia or elsewhere at any time within the previous 5 years of an offence punishable on conviction by imprisonment for a period of not less than 1 year; or

(b) is otherwise not, in the opinion of the Minister based on reasonable grounds, a fit and proper person to be a member of a panel.

Section 134 of the Act details that:

(1) The Minister may, in writing, appoint a person to act as the presiding member of a panel-

(a) during a vacancy in the office of presiding member, whether or not an appointment has previously been made to the office; or

(b) during any period, or during all periods, when the presiding member is absent from duty or from the Territory or is, for any other reason, unable to perform the functions of the office; but a person appointed to act during a vacancy shall not continue so to act for more than 12 months. Of the above eight members re-appointed pursuant to Section 131 of the Act, two were also previously appointed as an acting presiding member pursuant to Section 134 of the Act. They are now also re-appointed as presiding members pursuant to Section 134 of the Act. They are:
