DETERMINATION OF FEES

INSTRUMENT NO. 201 OF 1998

EXPLANATORY STATEMENT

The Land Titles Act 1925 governs the registration of dealings in land and the issue of certificates of title for land in the Australian Capital Territory. In particular, subsection 139(1) enables the Minister to determine fees for the purposes of the Act and Schedule 3 specifies the matters in the Act for which a fee may be determined.

This Determination revokes Determination of Fees No. 202 of 1997 made on 29 August 1997 and notified in the Australian Capital Territory Gazette No. S265 of 9 September 1997 and determines that the various fees payable under the Act, including fees for lodging, for registration and searching documents pertaining to land, shall be as set out in the schedule to the Determination.

The fee for item 4 has generally been increased by a margin of 1.8% in accordance with the anticipated movement in 1998/99 of the Consumer Price Index and with a view to full cost recovery.

The fees for items 6 & 7 have been \$14 and \$16 respectively for the last two financial years and are now increased to \$15 and \$17 respectively to reflect Consumer Price Index changes on a biennial basis (1.75% for 1997/98 and anticipated 1.8% for 1998/99) and with a view to full cost recovery.

The fees for items 1-3, 10-27, 29-33 and 35-37 have been increased by a margin of \$5 as a result of a Budget Cabinet Decision in line with the average lodgment fee across Australia.

The fees for items 9 and 28 have been increased by a margin of \$75 as a result of a Budget Cabinet Decision. The fee for item 9 recognises the higher rate payable payable under *ad valorem* schemes in other jurisdictions whilst the fee for item 28 is determined on the basis of the increased administrative cost associated with the new Caveat provisions in the Land Titles Act 1925.

The fees for items 5, 8 and 34 have not been increased as the CPI adjustment is less than 50 cents.
