DETERMINATION OF REGISTRATION FEES

INSTRUMENT NO. 184 OF 1998

EXPLANATORY STATEMENT

This determination revokes Determination No. 180 of 17 July 1998 and notified in Gazette No. S177 of 24 July 1998.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme (for vehicles with a GVM in excess of 4.5 tonnes) which the ACT Government is required to enforce under the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cwth).

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of changing fees for transactions relating to the registration of motor vehicles. The majority of fees have increased in accordance with the Government's decision to align registration fees with those in NSW. Fees for tractors, veteran, vintage, historic vehicles, golf carts and additional fees for original registration have increased in line with the Consumer Price Index.

Set out below for easy reference are the new fees and previous fees which apply to transactions relating to vehicle registration. The new fees will apply from 1 September 1998, and come into force immediately for all vehicle registrations which are due to expire on or after 31 August 1998.
