DETERMINATION OF FEES

NO 170 OF 1997

EXPLANATORY STATEMENT

This Determination revokes an existing Determination made under section 140 of the *Consumer Credit (Administration) Act 1996*, Determination No 250 of 1996 dated 1 November 1996 and notified in the Australian Capital Territory Gazette No S289 of 1 November 1996, and replaces it with a new Determination of fees made pursuant to section 140 of the *Consumer Credit (Administration) Act 1996*.

The *Consumer Credit (Administration) Act 1996* relates to the registration of Credit Providers and Finance Brokers. Section 140 enables the Minister to determine fees for the purposes of the Act

The fees have been increased by a margin of 1.75% in accordance with the anticipated movement in 1997/98 of the Consumer Price Index and with a view to full cost recovery. The fees for items 2, 4, 6, and 8 have not been increased because the increases have been rounded to the nearest dollar
