EXPLANATORY STATEMENT

This determination revokes Determination No 125 of 1997 of 24 June 1997 and notified in the Gazette No. S194 of 26 June 1997, and Determination No 13 of 1998 dated 14 January 1998 and notified in the Gazette No S28 of 14 January 1998

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of increasing fees for drivers' licences. Set out below are the new fees (and previous fees) which apply to transactions relating to drivers' licences.

The majority of fees have increased in line with the Consumer Price Index. There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs. The fees reflect the 1998-99 budget strategy of the Government and will take effect from 1 July 1998.
