## **DETERMINATION OF FEES AND CHARGES**

NO. 71 OF 1995

## **EXPLANATORY STATEMENT**

This Determination revokes Determination No. 69 of 1994 dated 22 June 1994 and published in the Australian Capital Territory Gazette No. S126 on 27 June 1994.

The Trade Measurement (Administration) Act 1991 provides for the administration of the Trade Measurement Act 1991 and related matters concerning "trade measurement legislation". Trade measurement legislation is defined in section 3 of the Trade Measurement (Administration) Act 1991 as including the Trade Measurement (Administration) Act 1991, Trade Measurement Act 1991, Weights and Measures (Sale of Bread) Act 1929 and regulations made under these acts.

Section 12(1) of the Trade Measurement (Administration) Act 1991 enables the Minister to determine fees for the purposes of trade measurement legislation. Fees have generally been increased by 4.0% in accordance with the anticipated movement in 1995/96 Consumer Price Index.

This determination increases fees in line with the Consumer Price Index for testing the accuracy of measuring instruments, and certification of approved instruments by Trade Measurement Inspectors. Section 10 of the Trade Measurement (Administration) Act 1991 provides for the owner of measuring instruments to pay a fee for the verification and reverification of the instruments.

Section 44(1) of the Trade Measurement (Administration) Act 1991 provides for licensing of private individuals and companies to certify measuring instruments and for a licence to operate a public weighbridge. Section 44(1) also provides for payment of an application fee in relation to these licences. Section 52(1) of the Act provides for payment of a fee for the licence itself which must be paid each year in order to renew the license. This determination increases these licence fees in line with the Consumer Price Index.

Subregulation 15(1) of the Trade Measurement (Weighbridges) Regulations made under the Trade Measurement Act 1991 provides for an application fee
