**DETERMINATION OF FEES**  
**NO. 77 OF 1995**  
**EXPLANATORY STATEMENT**

This instrument revokes *Determination of Fees number 106 of 1994* published in Australian Capital Territory Gazette Number S147 on 7 July 1994.

This determination sets fees for the purposes of the *Co-operative Societies Act 1939* and has the effect of increasing fees payable under the Act with effect from 1 July 1995.

The increase in fees is in line with the forecast increase in the rate of Consumer Price Index which is expected to be 3.5% in 1995-96.

Comparatives with 1994-95 fees are set out in column 4 of the attached schedule.
