DETERMINATION OF FEES

EXPLANATORY STATEMENT

This instrument revokes all existing fees determinations under the *Motor Traffic Act 1936*, namely:-

Determination No. 62 of 22 June 1994 published in the ACT Gazette No. S126 of 27 June 1994.

This determination sets fees for the purpose of the *Motor Vehicle (Dimensions and Mass) Act 1990* and has the effect of increasing Dimensions and mass permit fees for heavy vehicles effective on and from 1 July 1995. The fees are set out below, with previous fees shown in brackets.
