DETERMINATION OF FEES

NO. 128 OF 1997

EXPLANATORY STATEMENT

This determination revokes:

- Determination No 249 of 30 October 1996 and notified in Gazette No. S285 of 31 October 1996; and
- Determination No 288 of 5 December 1996 and notified in Gazette No. S334 of 12 December 1996.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme (for vehicles with a GVM in excess of 4.5 tonnes) which the ACT Government is required to enforce under the Road Transport Charges (Australian Capital Territory) Act 1993 (Cwth).

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of increasing fees payable for transactions which relate to vehicle registration. Set out below are the new fees (and previous fees) which apply to transactions relating to vehicle registration.

The majority of fees have increased in line with the Consumer Price Index. There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs. The fees reflect the 1997-98 budget strategy of the Government and will take effect from 1 July 1997.
