DETERMINATION OF FEES  
DETERMINATION NO. 129 OF 1997**

**EXPLANATORY STATEMENT**

This instrument revokes all existing fees determinations under the *Roads and Public Places Act 1937*, namely -

Determination No 120 of 19 June 1996 published in the ACT Gazette No S144 of 27 June 1996

This determination sets fees for the purpose of the *Roads and Public Places Act 1937* and has the effect of increasing the fee from 1 July 1997 for

- (a) the opening up or the breaking of the surface of a carriageway which has a surface of the type set out in Column 1 of Schedule 1 in relation to that type of surface, and
- (b) the fee for the opening up or the breaking of the surface of a public place, other than a carriageway, which has a surface of the type set out in Column 1 of Schedule 2 shall be the amount set out in a or ascertain in accordance with the formula in Column 2 of Schedule 2 in relation to that type of surface.

The fees have been increased by CPI and reflect the 1997-98 budget strategy of the Government. The new fees will take effect from 1 July 1997.

For ease of reference the new fees are set out below with previous fees shown in brackets.
