NO. 132 OF 1997

EXPLANATORY STATEMENT

This instrument revokes all existing fees determined under the Cemeteries Act 1933, namely

Determination of Fees Notice No 126 of 1996 published in Gazette No S144 of 27 June 1996

This determination sets fees for the purpose of the Cemeteries Act 1933 and has the effect of re-determining existing fees and determining fees for new services provided by the Canberra Public Cemeteries Trust on and after 1 July 1997

The fees payable are set out in the schedule to the instrument

Fees have been increased in line with the CPI and to effect full cost recovery for the provision of services Fees are similar to those charged in the States for like services 1996/97 fees have been carefully examined and every effort made to put the 1997/98 fees in as logical and simple format as possible

The fees payable are set out below with the corresponding 1996/97 fees shown in italics

RESERVATION FEES

A Certificate of Reservation can be purchased entitling the Certificate Holder to an Exclusive Right of Bural at some time during the next 25 years At the time of purchasing the Certificate, the relevant Allotment Fee, Maintenance Fee and interment fee must be pre-paid

Reservation of an un-specified allotment, or the adjacent allotment at the time of a burial (limit of one allotment paid for within one month at time of burial)

No Premium Fee

Reservation of a Specific Allotment.

Reservation Fee = 50% of relevant allotment fee.

Certificates of Reservation are renewable but will lapse if not renewed prior to the expiration of tenure
