# **INSTRUMENT NO. 204 OF 1997**

## EXPLANATORY STATEMENT

The Business Names Act 1963 governs the registration of business names in the Australian Capital Territory. In particular section 4A of the Act enables the Minister to determine fees for the purposes of the Act.

This Determination revokes Determination of Fees No. 236 of 1996 made on 16 October 1996 and notified in the Australian Capital Territory Gazette No. S271 of 22 October 1996 and determines that the fees payable for the purposes of the Act shall be as set out in the Schedule to the Determination

A statement of the old and new fees is attached.

Items 1 and 4 have not been increased. These fees were increased in 1996/97 by \$10 and \$13 respectively to bring items into line with fees charged in NSW The fees for comparable items in NSW are not to be increased this year and it has been decided that parity should be maintained

The fees for Items 3 and 7(ii) have been increased by a margin of 1.75% in accordance with the anticipated movement in 1997/98 of the Consumer Price Index and with a view to full cost recovery. The fees for other Items have not been increased as the CPI adjustment is less than 50 cents
