# AUSTRALIAN CAPITAL TERRITORY CO-OPERATIVE SOCIETIES ACT 1939 DETERMINATION OF FEES

NO. 106 OF 1994

#### **EXPLANATORY STATEMENT**

This instrument revokes determination of fees number 52 of 1993 published in Australian Capital Territory Gazette number 24 on 16 June 1993.

This determination sets fees for the purposes of the Co-operative Societies Act 1939 and has the effect of increasing fees payable under the Act with effect from 1 July 1994.

The increase in fees is in line with the forecast increase in the rate of Consumer Price Index which is expected to be 3% in 1994–95.

Comparatives with 1993-94 fees are set out in column 4 of the attached schedule.
