EXPLANATORY STATEMENT

This instrument revokes all existing fees determinations under the *Motor Traffic Act 1936*, namely:-

Determination No. 52 of 22 June 1994 published in the ACT Special Gazette No. S125 of 27 June 1994.

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of amending fees payable for transactions which relate to vehicle permits. Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to vehicle permits.

The majority of fees have remained unchanged with the exception of the fee for the grant of a licence to use a Motor Omnibus. This has been reduced from \$437 to \$100 to bring ACT fees for this service into line with NSW.
