
DETERMINATION No. 82 of 1990

Under Section 57(2) of the Motor Vehicles (Dimensions and Mass) Act 1990, I DETERMINE that for the purposes of Section 25(1) of the Act the mass of a wheel for the class of wheels fitted with pneumatic tyres is the lesser of -

- (a) the tyre manufacturer's maximum load rating in respect of the tyre, being the load rating in respect of the tyre listed, when the tyre was manufactured, in the tyre and rim standards manual of the country in which the tyre was manufactured; and
- (b) in the case of:
 - (i) a wide profile tyre on a non-steering single axle - 3.35 tonnes; or
 - (ii) any other tyre 3 tonnes.


DETERMINATION No. 83 of 1990

Under Section 57(2) of the Motor Vehicles (Dimensions and Mass) Act 1990, I DETERMINE that for the purposes of Section 25(2) of the Act the mass for the axle load of an axle for the class of axles set out in Column 1 of the Schedule is the amount specified in Column 2 of the Schedule opposite and in relation to each class of axle provided that the gross axle load rating specified by the manufacturer of the axle in respect of that axle is not exceeded.

For the purposes of this Determination, local services bus shall mean a bus or an articulated bus which has only single axles and which is licensed as a motor omnibus under the Motor Traffic Act 1936 to provide scheduled services over designated routes wholly within the Australian Capital Territory and is operating on one of those routes at the time.

MOTOR VEHICLES (DIMENSIONS AND MASS) ACT 1990


DETERMINATION No. 85 of 1990

Under Section 57(2) of the Motor Vehicles (Dimensions and Mass) Act 1990, I DETERMINE that for the purposes of Section 24(1)(c) of the Act the gross mass in tonnes for each class of vehicles "D" is 3L + 8, where L equals the overall axle spacing in metres.

For the purposes of this Determination "overall axle spacing" means the distance between the centre line of the most forward axle or, if the most forward axle forms part of a twin steer axle group, the forward axle of that group and the centre line of the most rearward axle or, if the most rearward axle forms part of an axle group, the most rearward axle of that axle group, being that distance measured while the centre line of the most forward axle or twin steer axle of the vehicle is parallel to the centre line of the most rearward axle or most rearward axle of the rear axle group of the vehicle.

MOTOR VEHICLES (DIMENSIONS AND MASS) ACT 1990


DETERMINATION No. 86 of 1990

Under Section 57(2) of the Motor Vehicles (Dimensions and Mass) Act 1990, I DETERMINE that for the purposes of section 24(2)(c) of the Act the gross mass in tonnes for each class of combination of vehicles "D" is 3L + 8, where L equals the overall axle spacing in metres and provided that the gross mass of a trailer (other than a semi-trailer) does not exceed the gross mass of the motor vehicle and provided that the maximum gross mass permitted shall not exceed 42.5 tonnes.

For the purposes of this Determination "overall axle spacing" means, in the case of a motor vehicle to which a trailer or semitrailer is attached, the distance between the centre line of the most forward axle or, if the most forward axle forms part of a twin steer axle group, the forward axle of that group of the motor vehicle to the centre line of the most rearward axle or, if the most rearward axle forms part of an axle group, the most rearward axle of that axle group of the trailer or semi-trailer, being that distance measured while the centre line of the centre of the most forward axle or twin steer axle of the motor vehicle is parallel to the centre line of the most rearward axle or most rearward axle of the rear axle group of the trailer or semi-trailer.
