



Invitation to Comment

The ACT Planning Authority is inviting comment on the planning concepts it proposes to use to control the development of six suburbs in Gungahlin.

Pursuant to Part 111 Division 2 of the Interim Planing Act 1990 the ACT Planning Authority has prepared a draft Variation to the Territory Plan for Gungahlin Suburbs H, M, N, O, R and W.

The purpose of the draft Variation is to seek public comment on the following proposals:

- The principals and policies for the subdivision and development of suburbs H, M, N, O, R and W.
- The identification of the land included in these suburbs as "defined land" for the purposes of Division 4 of Part 111 of the Interim Planning Act 1990.

The effect of describing this land as defined land is that its future subdivision is not subject to Division 2 of the Act. Detailed subdivision consistent with the principles and policies finally approved by the ACT Executive and not disallowed by the Legislative Assembly can then be approved by the ACT Planning Authority and added to the Territory Plan without another public consultation process.

The background papers in relation to this draft Plan include:

- 1. An explanatory statement
- 2. Recommendations of the Conservator of Wildlife.
- A Preliminary Assessment of the Existing Environment, Infrastructure and Required Facilities and Potential Impacts and Safeguards; and
- 4. Outline Implementation Plans for each suburb.

Copies of the draft Variation and background papers relating to the draft Variation are available free of charge from the office of the ACT Planning Authority, John Overall Offices, 5th floor, 220 Northbourne Avenue Braddon 2601. A copy of these documents is also available for inspection at the Authority's office and the ACT shopfront, ground floor 220 Northbourne Avenue Braddon between 9.00 am and 4.30 pm Monday to Friday (except public holidays).

This draft Variation is to have interim effect under the provisions of section 9 of the Act for the "defined period"

"defined period" means the period commencing on the date the draft Plan Variation is notified in the Gazette under section 13 and terminating at the expiration of the day before -

- . (a) the date the draft Variation comes into effect;
 - (b) the date the draft Variation is rejected by the Legislative Assembly;
 - (ba) the date the Executive revokes its approval of the Variation; or
- (c) the date the draft Variation is withdrawn under paragraph 16 (1) (c), 20 (a) or 22 (4) (b); as the case requires.

This means that during this period no development can be approved unless it complies with both the existing policies and the draft Variation if it were approved.

INSTRUMENT OF APPROVAL UNDER SECTION 10

Under section 10 of the City Area Leases Act 1936 I CARL JAMES THOMPSON APPROVE of JOHN HERCULES BAIRD ("the Applicant") carrying on the profession trade occupation or calling of GUNSMITH ("the business") on Block 8 Section 44 Division of SPENCE known as 15 GARRARD STREET SPENCE ("the land") subject to the following conditions relating to the use of the land being observed by the Applicant in carrying on the business -

- that this approval will remain valid only while the Applicant continues to be a bona fide resident of the land;
- 2 that the Applicant will ensure that the conduct of the business does not cause an annoyance a nuisance or danger and is not offensive to any tenants or occupiers of adjoining lands;

- that no person other than the Applicant will conduct or in any way carry on the business on the land without the prior approval of the Minister;
- 6 that the Applicant will not employ any assistants for the purpose of conducting or carrying on the business on the land without the prior approval of the Minister;
- 7 that the Applicant will not employ any assistants for the purpose of conducting or carrying on the business on the land without the prior approval of the Minister;
- 8 that the business will only be conducted on the land between the hours of 8.00am and 10.00pm Monday to Friday and 8.00am and 6.00pm Saturday for a maximum of 20 hours per week;

- 9 that this approval will terminate on the THIRTY FIRST day of JULY 1992 or on such earlier date as the Minister determines in accordance with condition 10;
- upon any failure to comply with any or all of the foregoing conditions the Minister or his Delegate under the said Act may give written notice requiring the Applicant to show cause within a period of fourteen days why this approval should not be revoked. At the expiration of this period the Minister or his Delegate may revoke the approval.
