



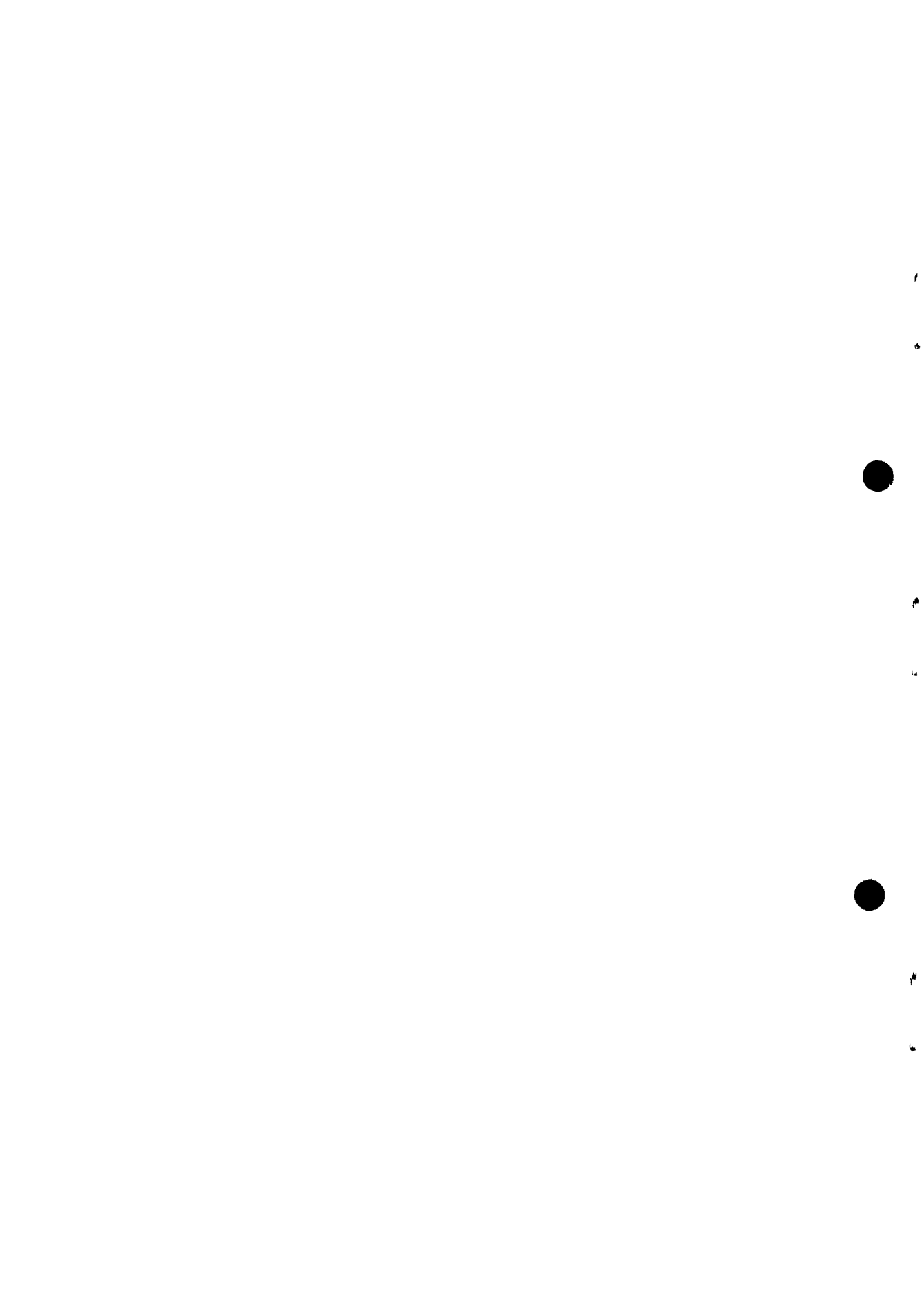

GOVERNMENT NOTICES

INTERIM PLANNING ACT 1990 DRAFT TERRITORY PLAN

The ACT Planning Authority has prepared the draft Territory Plan and invites public comment on it pursuant to section 13 of the Interim Planning Act 1990.

The draft Territory Plan defines land use policies and development criteria for all land in the ACT excluding "Designated" land under the National Capital Plan and Jervis Bay. The draft Plan comprises a map and an accompanying written statement.

DRAFT TERRITORY PLAN MAP

The draft Territory Plan map indicates which policies apply to different areas of land. Planning Policies have been developed for particular land use categories such as residential, commercial, industrial, community facilities etc. These Predominant Land Use Zones are differentiated by the use of different colours on the map.

WRITTEN STATEMENT

The written statement contains the principles and policies indicated on the map. It is divided into four main sections:

ADMINISTRATION

This Part deals with general administrative matters associated with the Plan.

PLANNING PRINCIPLES

These form the broad planning framework for the Territory Plan and the way it may evolve. The principles are statements which aim to guide future actions and decisions about changes to the Plan and are generally broader and less specific than the policies in content.

PREDOMINANT LAND USE ZONE POLICIES

These are the main instruments for land use and development control in the Plan. They identify the objectives for each area, the types of land uses which may be permitted and planning controls and development criteria which may apply.

GENERAL POLICIES

In addition to the Predominant Land Use Zone policies there are a number of general planning policies which are proposed to be incorporated in the Plan such as those relating to water resource management.

In addition to the statutory components of the Territory Plan, an accompanying "Planning Report" is available. This is essentially an explanatory document which discusses the background to the Plan, identifies key planning issues, responses and trade-offs which have been made in preparing the Plan, and contains a guide to how the Plan operates.

To assist the community to understand the draft Plan and to formulate their responses to it the Authority has prepared an exhibition which will be located at:

The Canberra Centre in Civic from 24 October 1991 to 9 November 1991.

This exhibition will be staffed at the following times:

Monday to Thursday	11.30 am to 2.30 pm
Friday	11.30 am to 9.00 pm
Saturday	9.00 am to 3.00 pm

Smaller unstaffed displays will be located at the Woden, Belconnen and Tuggeranong Libraries from 24 October 1991 to 23 November 1991.

Copies of the draft Territory Plan and Planning Report may also be inspected at all ACT Government Libraries and the ACT Planning Authority. Copies of the documents may be purchased from the Shopfront, Department of the Environment, Land and Planning, Ground Floor, 220 Northbourne Avenue, Braddon. Cost of the draft Territory Plan and the Planning Report is \$10.00 each.



AUSTRALIAN CAPITAL TERRITORYCITY AREA LEASES ACT 1936INSTRUMENT OF APPROVAL UNDER SECTION 10

Under section 10 of the City Area Leases Act 1936 I CLAUDIA-LUCE BOTTRILL APPROVE of PETER WATERMAN AND ADRIANNE WATERMAN ("the Applicant") carrying on the profession trade occupation or calling of ENVIRONMENTAL MANAGEMENT AND PLANNING CONSULTANTS ("the business") on Block 32 Section 35 Division of HOLDER known as 40 DIXON DRIVE HOLDER ("the land") subject to the following conditions relating to the use of the land being observed by the Applicant in carrying on the business -

- 1 that this approval will remain valid only while the Applicant continues to be a bona fide resident of the land;
- 2 that the Applicant will ensure that the conduct of the business does not cause an annoyance a nuisance or danger and is not offensive to any tenants or occupiers of adjoining lands;
- 3 that the Applicant will not erect or permit or suffer to be displayed or erected upon the land or any building thereon any advertising sign or hoarding whatever without the consent in writing of the Australian Capital Territory Planning Authority and the Building Controller;
- 4 that the Applicant will conduct the business strictly in accordance with the application made by the Applicant under section 10 of the City Area Leases Act 1936 unless otherwise stipulated in this Instrument;
- 5 that no person other than the Applicant will conduct or in any way carry on the business on the land without the prior approval of the Minister;
- 6 that the Applicant will ensure that all residence and business related vehicles are parked within the confines of the land;
- 7 that the Applicant will not employ any more than one assistant for the purpose of conducting or carrying on the business on the land without the prior approval of the Minister;
- 8 that only the approved area of the house be used for the conduct of the business;

- 9 that the business will only be conducted on the land between the hours of 9.00 am and 5.00 pm Monday to Friday;
- 10 that the Applicant will conduct the business strictly by appointment, and that such appointments will be organised to ensure that no more than two clients are in attendance at any one time;
- 11 that this approval will terminate on the THIRTIETH day of SEPTEMBER 1992 or on such earlier date as the Minister determines in accordance with condition 11;
- 12 upon any failure to comply with any or all of the foregoing conditions the Minister or his Delegate under the said Act may give written notice requiring the Applicant to show cause within a period of fourteen days why this approval should not be revoked. At the expiration of this period the Minister or his Delegate may revoke the approval.


