

The closure will not prevent public right of way over the land and access is to be maintained by the successful developer under the terms and conditions contained in the formal agreement to be entered into by the developer and the government, which requires that "Gundaroo Road shall remain open to public traffic until William Slim Drive or an approved alternative route is open to traffic".
