adjacent to section 126, suburb of Wanniassa in






This is Plan Number 1 annexed to Instrument No. 4791 signed on this 75th day of 1991.





Closure will not prevent public right of way over the land and access will be maintained in a manner identical with current arrangements.



This is Plan Number 3 annexed to Instrument No. 4/91 signed on this 3 day of 1991.



This is Plan Number 4 annexed to Instrument No. 1/91 signed on this day of 1991.


Delegate's Initials NOTE: Closure of this road is to allow for the amalgamation and redevelopment of Blocks 1 and 2. The proposed development provides for pedestrian access to be maintained over the existing footpath between Mountevans Street and Heard Street carpark. The proposed variation would also provide future opportunities for adjacent clubs to facilitate potential redevelopments.
