DRAFT VARIATION TO THE TERRITORY PLAN AND PRELIMINARY ASSESSMENT

FOR

GUNGAHLIN (PART OF NICHOLLS) INCLUDING THE GOLD CREEK TOURIST AREA

(PROPOSED "HARCOURT HILL" DEVELOPMENT)

The ACT Planning Authority is inviting comment on a proposed Land Use Policy change for Gungahlin (part of Nicholls), including the Gold Creek Tourist Area.

It is proposed to change the existing Land Use Policies to:

- permit an integrated residential, golf course and tourist development over the southern section of the area, to be known as "Harcourt Hill"; and
- make some minor changes to the previously planned pattern of open space, community facilities, residential and commercial uses in the northern part of Nicholls.

Printed by Liz Harley, ACT Government Printer by the authority of the ACT Executive The land included in this draft Variation to the Territory Plan is proposed to be "Defined Land" as prescribed under section 7(3)(e) of the Land (Planning and Environment) Act 1991.

In addition, a Preliminary Assessment of potential environmental impacts of this draft Variation to the Territory Plan has been undertaken, as set out in the Land (Planning and Environment) Act 1991.
