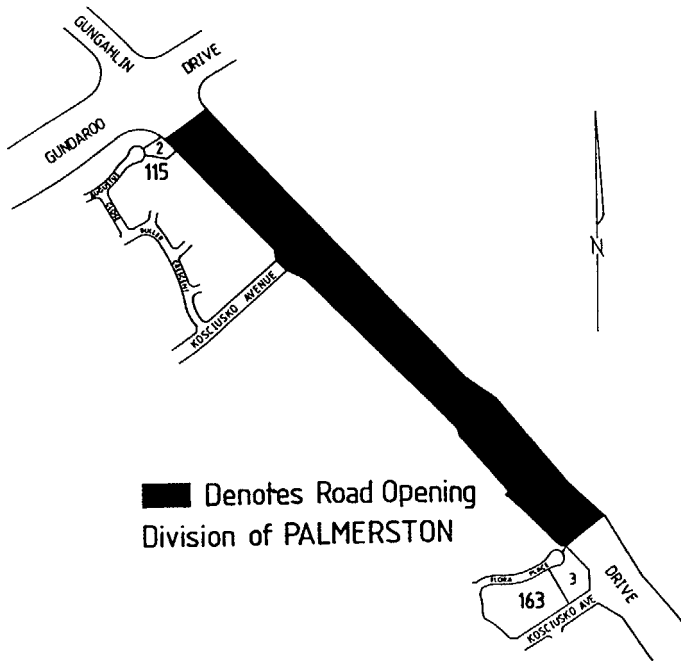

All that land in the Australian Capital Territory, shown in thick black line on the plans annexed hereto:

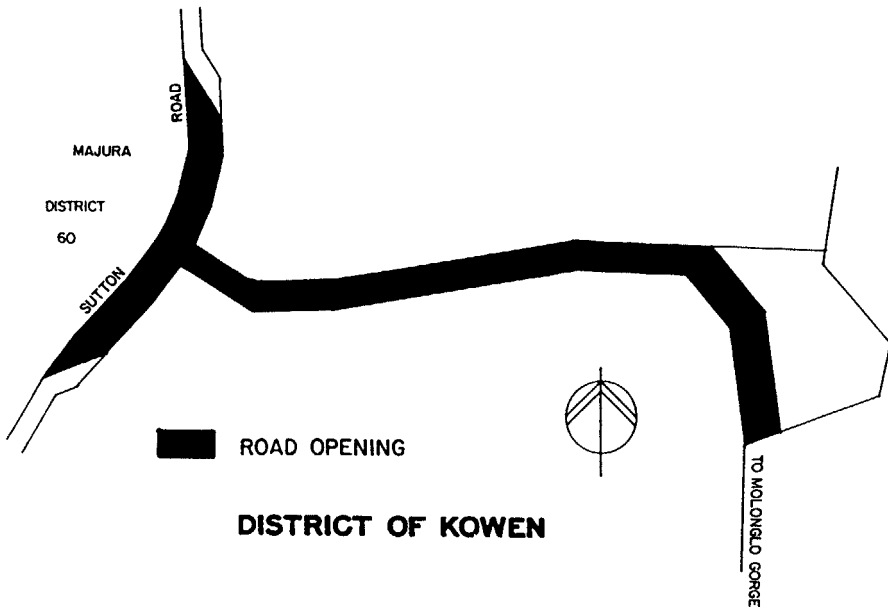
Plan No. 1 Part of the road known as Gungahlin Drive in the District of Gungahlin.



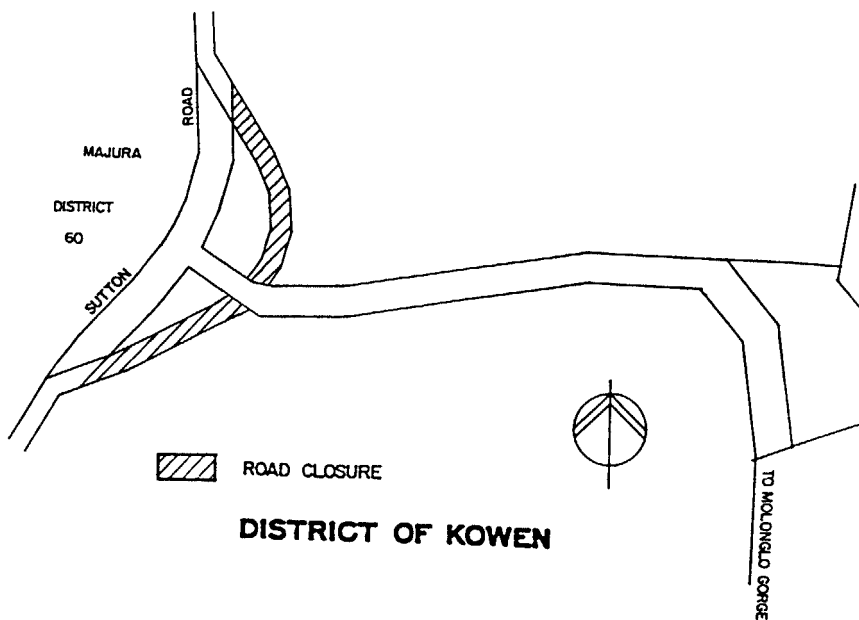
