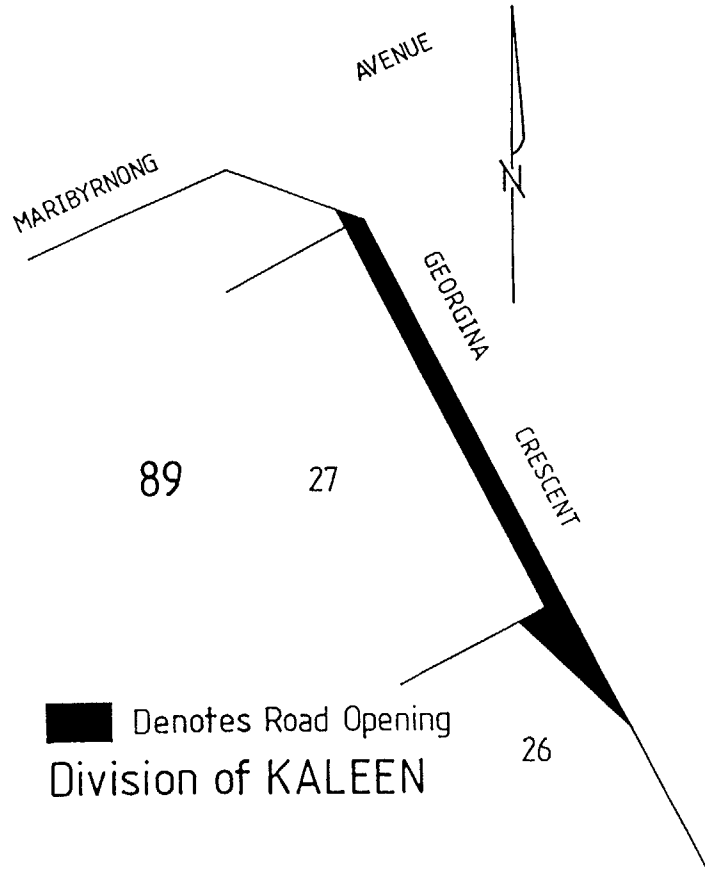

Plan No. 1 Part of the road known as Georgina Crescent adjacent to Section 89 in the Division of Kaleen in the District of Belconnen.





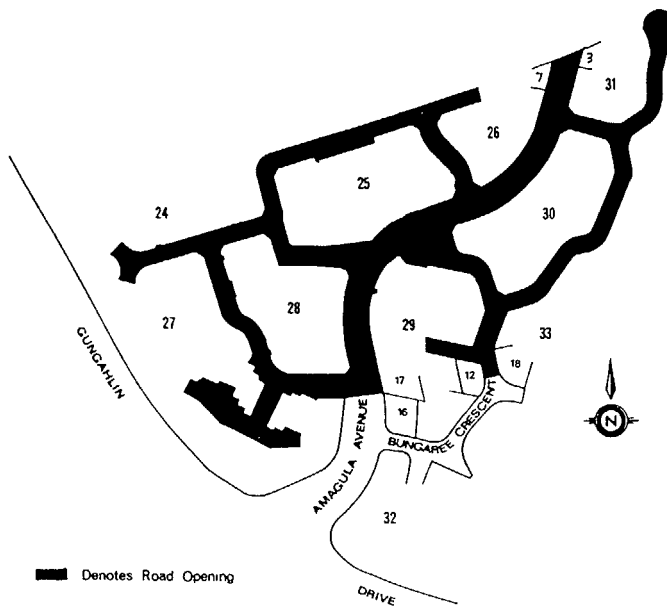
