BETTING (TOTALIZATOR ADMINISTRATION) ACT 1964

DETERMINATION

DETERMINATION NO. 31 OF 1993

Pursuant to subsection 7(2) of the Betting (Totalizator Administration) Act 1964 I DETERMINE that the proportion of the amount determined under subsection 7(3) that shall be paid to each declared race club shall be:

- (a) an amount equal to 2.3% of the amount of bets accepted by the TAB paid in the following proportion:
  - (i) ACT Racing Club Inc - 75%;
  - (ii) Canberra Greyhound Racing Club Inc - 15%; and
  - (iii) Canberra Harness Racing Club Inc - 10%.
- (b) an amount equal to the total amount of fees for standing licences collected under section 29 of the Bookmakers Act 1985 during the preceding month (up to a limit of 1.2% of the amount of bets accepted by the TAB in the terms of subsection 7(1) of the Betting (Totalizator Administration) Act 1964), in the following proportions:
  - (i) to the ACT Racing Club Inc, the proportion that fees for standing licences collected at race meetings under its control during the preceding month bears to the total fees for standing licences collected at all race meetings conducted by declared race clubs in the Australian Capital Territory during the preceding month;

- (ii) to the Canberra Greyhound Racing Club Inc, the proportion that fees for standing licences collected at race meets under its control during the preceding month bears to the total fee for standing licences collected at all race meetings conducted by declared race clubs in the Australian Capital Territory during the preceding month; and
  - (iii) to the Canberra Harness Racing Club Inc, the proportion that fees for standing licences collected at race meets under its control during the preceding month bears to the total fee for standing licences collected at all race meetings conducted by declared race clubs in the Australian Capital Territory during the preceding month.
- (c) Where the amount of the total of fees for standing licences is less than 1.2% of the amount set aside under 7(1) then the difference between the total of the fees and the 1.2% of the amount of bets accepted by the TAB in the terms of subsection 7(1) shall be paid to each declared race club in the following proportion:
- (i) ACT Racing Club Inc - 75%;
  - (ii) Canberra Greyhound Racing Club Inc - 15%; and
  - (iii) Canberra Harness Racing Club Inc - 10%.
