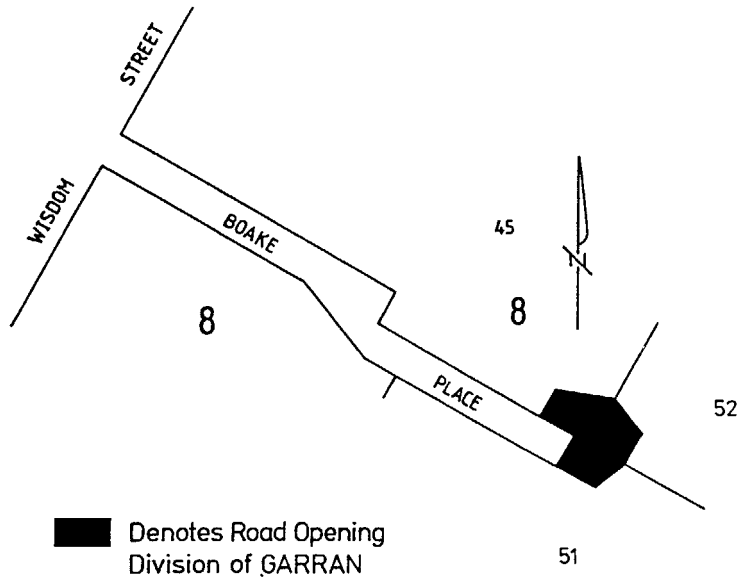



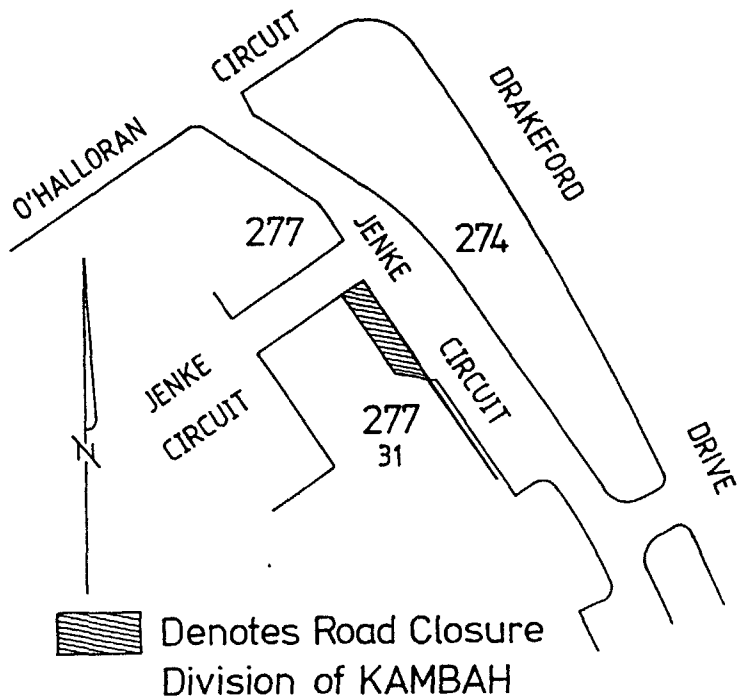

Plan No. 1: Part of the road known as Winsler Crescent within Section 19 in the Division of Kambah in District of Tuggeranong.

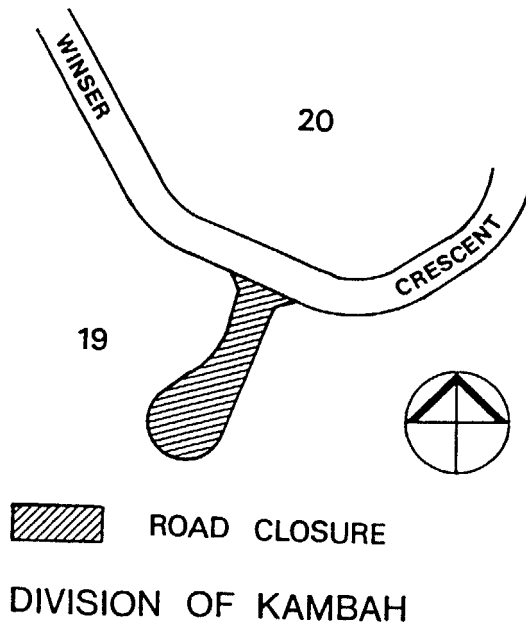
Plan No. 2: Part of the road known as Jenke Circuit adjacent to Block 31 Section 277 in the Division of Kambah in the District of Tuggeranong.

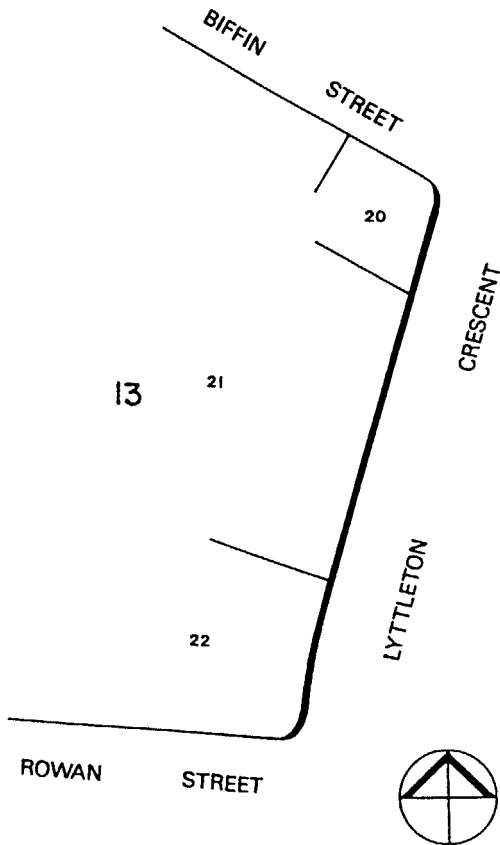
