CONSUMER PRODUCT SAFETY ORDER

Under Section 15FC (3) of the *Consumer Affairs Act 1973*, I revoke the Consumer Product Safety Order dated 30 January 1992 as notified in the ACT Government Gazette No 6 of 12 February 1992 and under Section 15FC (1) of the *Consumer Affairs Act 1973* order that

- 1. The supply of goods set out in Schedule 1 is prohibited.
- 2 The supply of a device known as "Vomiting Infants Support Association (V.I.S.A) Harness" designed and intended to support and position a child in a cot or bed when the cot or bed is inclined at an angle of up to 30 degrees, is prohibited from sale unless the goods comply with the conditions set out in Schedule 2.

being satisfied that the order is reasonable and necessary to prevent or reduce the risk of injury to, or impairment of health, of any person arising out of the possession, handling or use of those goods by that person or any other person
