



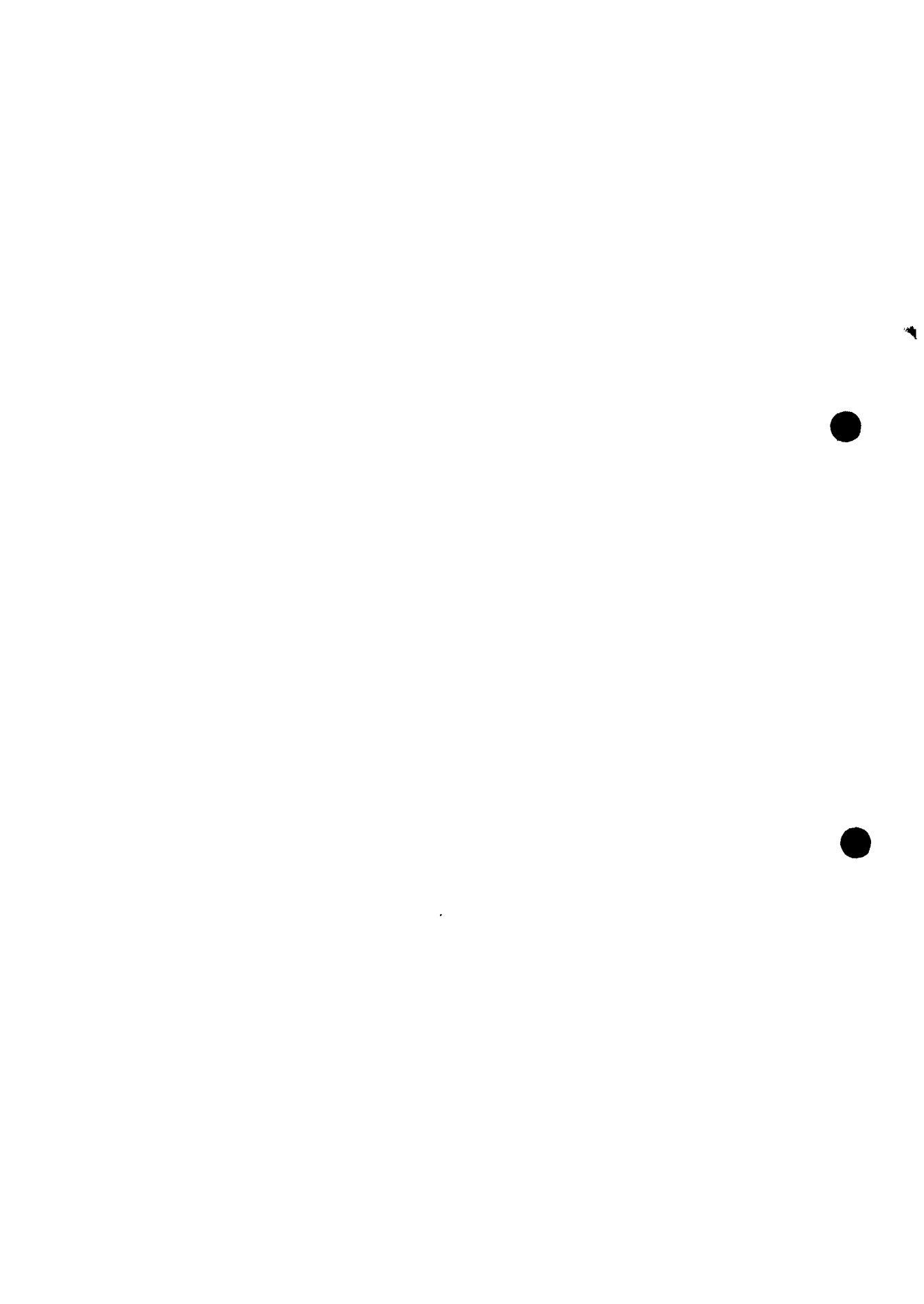


#### PROVISIONAL PROMOTIONS MADE UNDER SECTION 29

## Categories used in this Gazette
