Politics, the media and building a safer society

An address by

Professor John Braithwaite

of the Research School of Social Sciences, Australian National University, at the National Press Club

Professor Braithwaite will speak on a range of issues including institutional reform in the nation's criminal justice systems, the community conferencing system for offenders and victims of crime which is being piloted in ACT, wastage of public funds in our police and prison systems and the political and social costs of "political bidding competitions" to get tough on crime.

Professor Braithwaite is author of the book, *Crime, Shame, and Reintegration* which has provided the theoretical rationale for community conferencing. The book has won three international awards including the American Society of Criminiology Award for the most important contribution to criminology in the previous three years.

General Medical Practice in Australia Beyond 2000

An address by

Professor Bob Douglas

Director, National Centre for Epidemiology and Population Health, Australian National University, at the National Press Club

Professor Douglas will discuss the remuneration of general practitioners, their current maldistribution, the likely impact of computer and "smart card" technology on health care, and the implications of the COAG health and community services reforms announced in April. He will argue that general practitioners must play a new and vital role in the Australian health care system as the COAG reforms unfold and that this will require adjustment not only by GPs but also by their patients.
