## MILK AUTHORITY OF THE AUSTRALIAN CAPITAL TERRITORY

## **MILK AUTHORITY ACT 1971**

The Milk Authority of the Australian Capital Territory, in pursuance of Section 16A of the Milk Authority Act 1971, hereby fixes and declares:

- 1. This notice takes effect on Saturday 1 July 1995.
- All Gazette notices published prior to the date of this notice pursuant to Section 16A of the Milk Authority Act 1971 are hereby revoked.
- 3. Pursuant to Section 16A(1) of the Milk Authority Act 1971:
  - (a) The maximum price at which packaged milk (pasteurised or pasteurised and homogenised, including modified milk and flavoured milk as specified) may be sold by retail is fixed at and declared to be:

- 5. The total value of a purchase made at retail which comprises or includes a milk product or milk products specified herein, the cash register total of which ends in 8 cents or 9 cents, may be rounded by retailers to the nearest 10 cents.
- 6. The "Hospitality Pack" shall not be sold at retail.
- Bottles of 2 litres labelled as Cannons Milk shall not be sold to or by the holders of Milk Vendors Licences or Milk Vendors Permits.
- 8. This notice does not apply in the Jervis Bay Territory.
