EFFECT OF INCLUSION IN AN INTERIM REGISTER

Pursuant to section 55 of the Land (Planning and Environment) Act 1991, during the defined period an interim Heritage Places Register has effect as if it were the Heritage Places Register

The Interim Heritage Places Register is in the form of an interim variation to the Heritage Places Register. During the defined period the Territory, the Executive, a Minister, or a Territory authority shall not do any act, or approve the doing of any act, which would be inconsistent with the Heritage Places Register, as if it were varied in accordance with the interim variation.

The 'defined period' referred to above means the period commencing on the date of publication of this notice and terminating on the expiration of the day before the date a variation to the Heritage Places Register prepared in consideration of this interim Register comes into effect under section 30, or

- · the interim Heritage Places Register is revised by the Council under s 62,
- the corresponding draft Plan variation is withdrawn by the ACT Planning Authority,
- · the Executive revokes its approval of the corresponding Plan variation,
- the corresponding Plan variation is withdrawn by the ACT Assembly, or withdrawn by the Minister under s 29

REVIEW OF DECISION

Pursuant to section 86(2) of the Land (Planning and Environment) Act 1991, a person whose interests in relation to land are affected may apply to the Land and Planning Appeals Board for a review of the above decision of the Heritage Council to include a provision, in respect of a place listed above, in an interim Heritage Place Register
