RATES AND LAND TAX ACT 1926

EXEMPTION FROM PAYMENT OF RATES AND LAND TAX

Under Section 28 of the Rates and Land Tax Act 1926 I exempt the owners of the land specified in the attached schedule from payment of the fixed charge of \$220, 50 per centum of the valuation based rates, and land tax charges in respect of those properties for the period 1 July 1997 to 30 June 1999, subject to the condition that the exemption shall apply only while the land continues to be used primarily for primary production.
