NOTICE

On 18 August 1997 the ACT Executive, pursuant to paragraph 26(1)(a) of the Land (Planning and Environment) Act 1991, approved:

Variation No.55 to the Territory Plan entitled Provisions for Temporary Care Accommodation; and

Variation No.64 to the Territory Plan entitled B2 Commercial Land Use Policies - Local Centres (Part B2D).

In accordance with subsection 29(6) of the Land (Planning and Environment) Act 1991 the Plan Variations were tabled before the Legislative Assembly and had not been disallowed or deemed to be disallowed as at 23 September 1997.
