Plan No. 3 : The land within Sections 86 and 89 in the Division of Nicholls in the District of Gungahlin.


Plan No. 4 : The land within Sections 24, 58, 60, 71 and 72 in the Division of Nicholls in the District of Gungahlin.

Plan No. 5 : The land within Sections 134 to 136 and 170 in the Division of Ngunnawal in the District of Gungahlin.

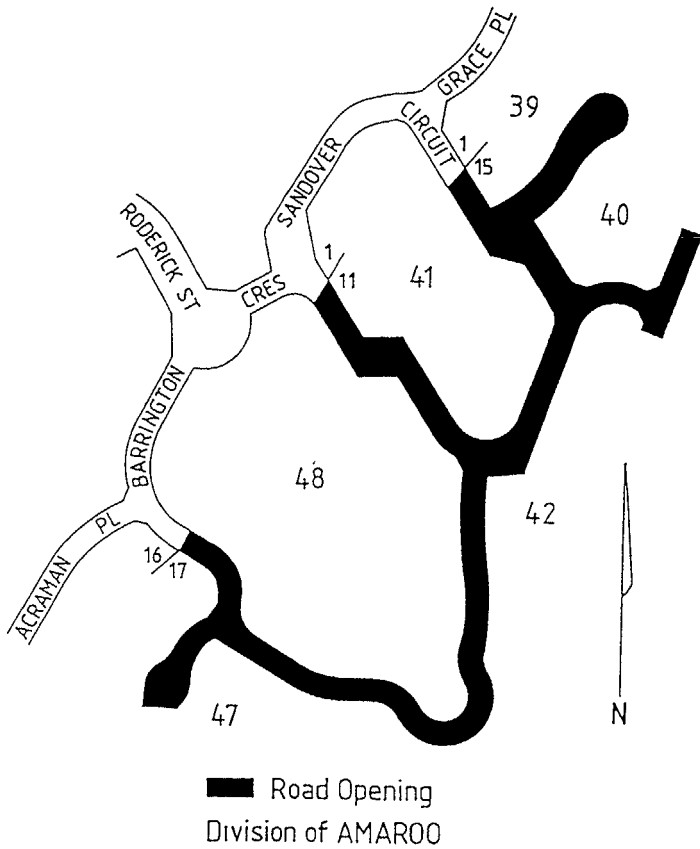
Plan No. 6 : The land within Section 14 in the Division of Belconnen in the District of Belconnen.

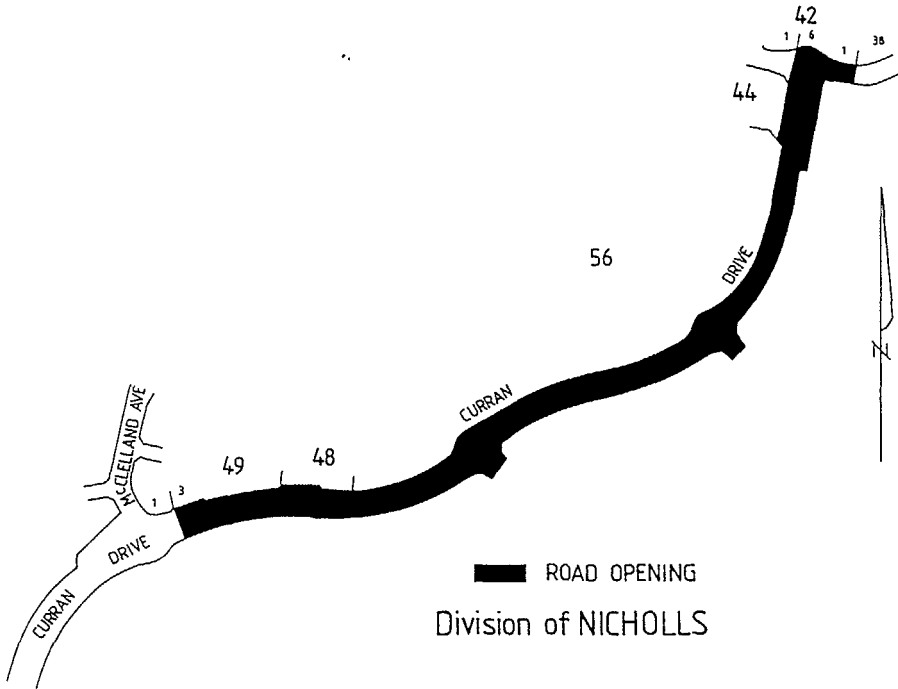

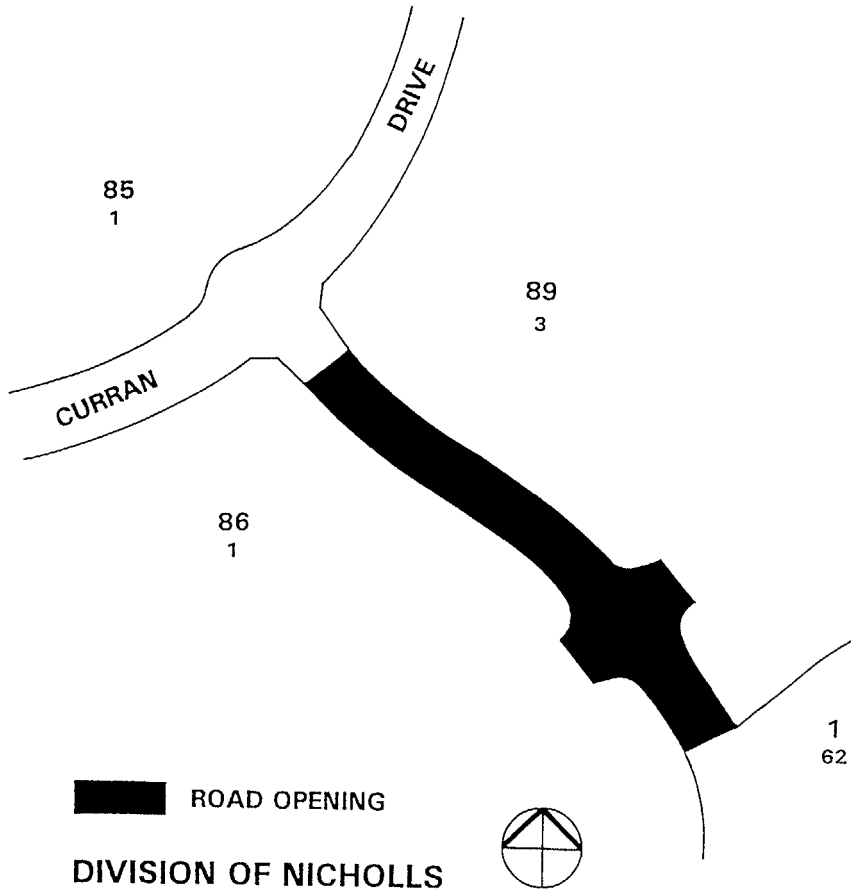

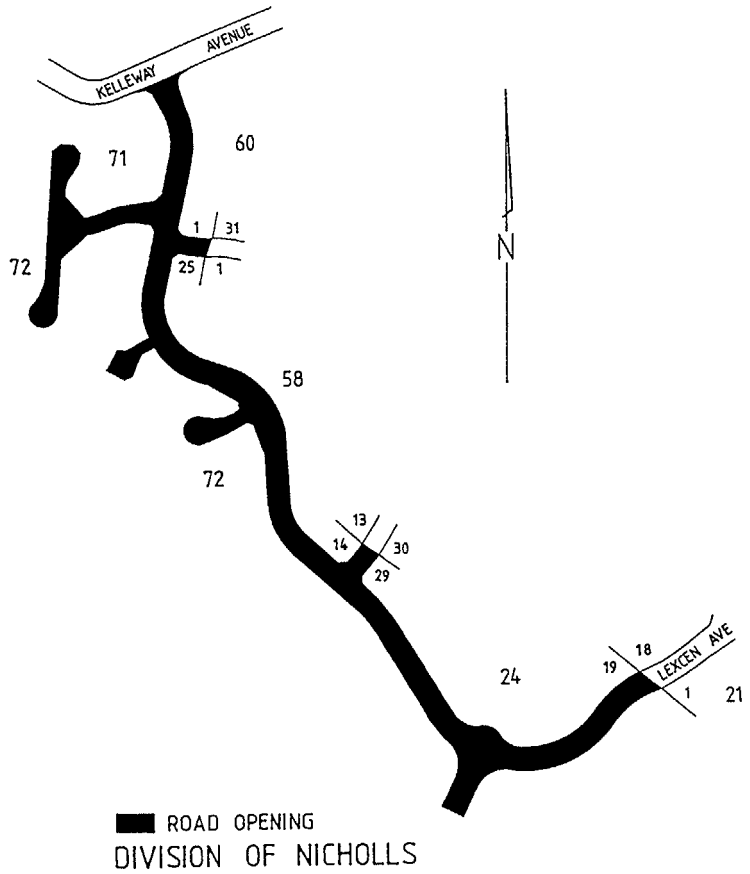
This is Plan Number Two annexed to Instrument No. R6/97 signed on this *4th*

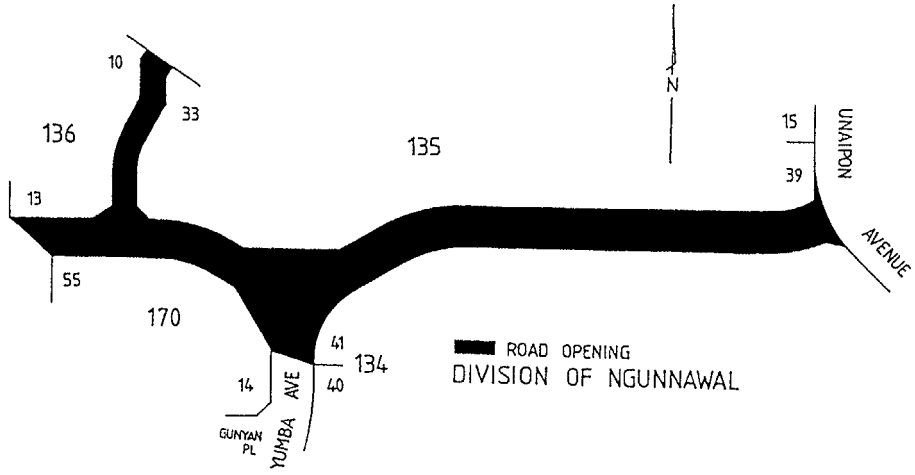

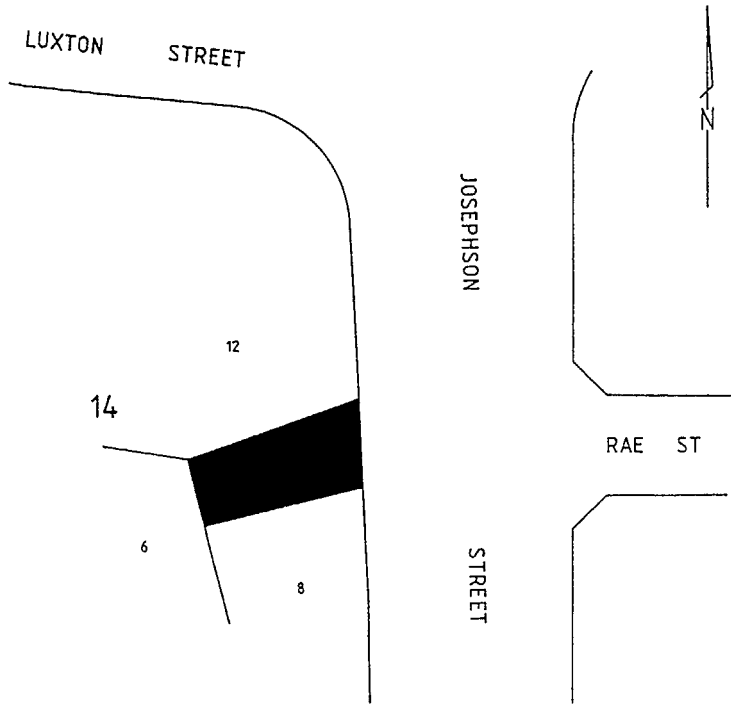

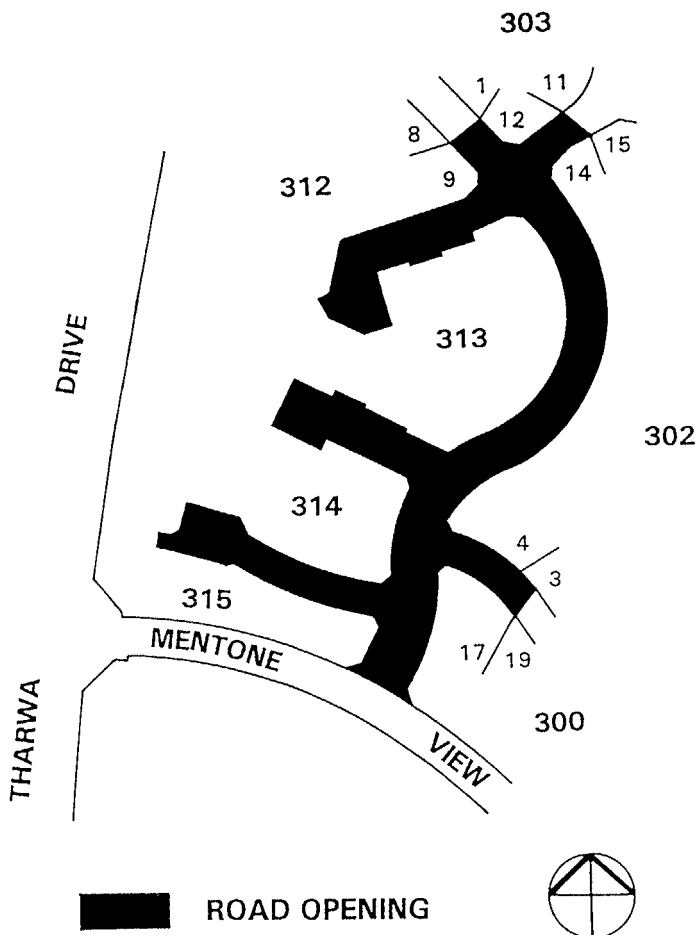


■ ROAD OPENING
