The contract period will be two (2) years on a ‘needs’ basis, and will consist of two (2) phases as follows:

- a. The first phase, involving the development of procedures, **must** be completed by **30 September 1998**, allowing for the immediate consideration of applications currently pending; and
- b. Phase 2 will commence immediately upon the completion of Phase 1 and will require the undertaking of evaluations of interactive gambling proposals and the refinement of procedural documentation over the duration of the contract period.
