#### **DETERMINATION OF FEES**

#### **EXPLANATORY STATEMENT**

#### **INSTRUMENT No. 149 OF 2001**

This Determination made under section 144 of the **Domestic Animals Act 2000** (the Act) sets the fees for the purposes of the Act. The Act repeals and replaces the *Dog Control Act 1975*. The fee determinations under the *Dog Control Act* will not have any force or effect from the date of repeal of that Act.

The Act regulates the ownership of dogs within the ACT and sets fees for:

- the registration of a dog;
- replacing a tag or certificate of registration;
- a licence for keeping a dangerous dog;
- a licence for keeping four or more dogs;
- a permit to keep an animal (dog / cat) sexually entire;
- the return and transport of a dog impounded under the Act;
- providing a certified copy of a certificate of registration;
- impounding a dog.

The determination also sets the parameters for the Registrar to refund, in full or part, fees payable under this determination.

The initial registration fee for a dog that is younger than 1 year has been set at a zero amount. This is to encourage owners of dogs to comply with the requirement of dog registration. A fee has been determined for the initial registration of a dog over one year of age. This is to ensure that owners do not continually register their dog as a 'new' registration on an annual basis.

Fees for the return of an impounded dog are simplified and aligned more closely with the actual costs involved in holding dogs at the pound.

To encourage responsible disposal of unwanted dogs Domestic Animal Services provides services in relation to euthanasing and disposing of those dogs. Fees for these services are set by this determination.

A Permit to Keep an Animal Sexually Entire is a new requirement in this determination. The fee for this permit is a once off payment and only applies to animals born after 21 June 2001. The fee has been set at a reasonably high level to ensure that owners do not simply opt for a permit to keep their animals sexually entire instead of choosing to desex them. Pensioners and benefit recipients receive this Permit at a reduced rate. The parameters concerning circumstances surrounding the refunding of fees paid for this Permit are contained within this determination as required by section 144(3)(c) of the Act.
