DIRECTION UNDER SUBSECTION 37(1)

WHEREAS:

- A. You are the public servant performing the duties of the Government Service Office which, under subsection 33(3) of the Land (Planning and Environment) Act 1991 (the Land Act), constitutes the ACT Planning Authority; and
- B. The ACT Executive has considered the Legislative Assembly resolution of Thursday 14 June 2001 which states:

"That, pursuant to subsection 37 (2) of the Land (Planning and Environment) Act 1991, the Legislative Assembly recommend to the Executive that the ACT Planning Authority be directed to review the Territory Plan as it relates to Block 1, Section 72 and Block 1, Section 80, Watson to consider whether or not to permit residential development or to change the land use policy to Urban Open Space or Hills, Ridges and Buffer Areas with a Public Land - Nature Reserve overlay."

THE ACT EXECUTIVE HEREBY GIVES THE FOLLOWING DIRECTION under subsection 37(1) of the Land Act:

The ACT Planning Authority shall review the Territory Plan as it relates to Block 1, Section 72 and Block 1, Section 80, Watson to consider whether or not to permit residential development or to change the land use policy to Urban Open Space or Hills, Ridges and Buffer Areas with a Public Land - Nature Reserve overlay.
