INSTRUMENT OF APPROVAL UNDER SECTION 10

Under section 10 of the City Area Leases Act 1936 I CARL JAMES THOMPSON APPROVE of BRIAN LESLIE KOOREY AND LORRAINE MAE KOOREY ("the Applicant") carrying on the profession trade occupation or calling of RESTAURATEURS AND CATERERS ("the business") on Block 10 Section 83 Division of NARRABUNDAH known as 15 SPRENT STREET NARRABUNDAH ("the land") subject to the following conditions relating to the use of the land being observed by the Applicant in carrying on the business -

- that this approval will remain valid only while the Applicant continues to be a bona fide resident of the land;
- that the Applicant will ensure that the conduct of the business does not cause an annoyance a nuisance or danger and is not offensive to any tenants or occupiers of adjoining lands;
- that the Applicant will not erect or permit or suffer to be displayed or erected upon the land or any building thereon any advertising sign or hoarding whatever without the consent in writing of the Interim Territory Planning Authority and the Building Controller;
- that the Applicant will conduct the business strictly in accordance with the application made by the Applicant under section 10 of the City Area Leases Act unless otherwise stipulated in this Instrument;
- that no person other than the Applicant will conduct or in any way carry on the business on the land without the prior approval of the Minister:

- that the Applicant will ensure that all residence and business 6 related vehicles are parked within the confines of the land;
- that the Applicant will not employ more than two casual assistants 7 who are required to work different hours for the purpose of conducting or carrying on the business on the land without the prior approval of the Minister;
- that only approved rooms in the house be used for the conduct of 8 the business:
- that the business will only be conducted on the land between the 9 hours of 9.00 am and 4.00 pm Monday to Friday and that catering staff may have access to equipment and supplies only during these hours and between the hours of 9.00 am and 12.00 noon on Saturdays and Sundays:
- that the Applicant will conduct the business strictly by 10 appointment, and that such appointments will be organised to ensure that no more than two visitors are in attendance at any one time;
- that no commercial food preparation takes place on the premises; 11
- 12 that there are no commercial signs displayed on the premises advertising a business operation;
- 13 that this approval will terminate on the THIRTIETH day of SEPTEMBER 1990 or on such earlier date as the Minister determines in accordance with condition 14;
- 14 upon any failure to comply with any or all of the foregoing conditions the Minister or his Delegate under the said Act may give written notice requiring the Applicant to show cause within a period of fourteen days why this approval should not be revoked. At the expiration of this period the Minister or his Delegate may revoke the approval.
