## CITY AREA LEASES ACT 1936

## INSTRUMENT OF APPROVAL UNDER SECTION 10

Under section 10 of the City Area Leases Act 1936 I BARBARA DAWN FORREST APPROVE of SUSAN PATRICIA HALL ("the Applicant") carrying on the profession trade occupation or calling of ART GALLERY PROPRIETOR ("the business") on Block 14 Section 61 Division of GRIFFITH known as 14 BREMER STREET GRIFFITH ("the land") subject to the following conditions relating to the use of the land being observed by the Applicant in carrying on the business -

- that this approval will remain valid only while the Applicant continues to be a bona fide resident of the land;
- 2 that the Applicant will ensure that the conduct of the business does not cause an annoyance a nuisance or danger and is not offensive to any tenants or occupiers of adjoining lands;
- that the Applicant will not exhibit any notice, advertisement, sign or hoarding on the property. In accordance with your application, a sign up to 500mm x 300mm in size indicating the name and occupation of the resident, can only be exhibited on the dwelling house;
- that the Applicant will conduct the business strictly in accordance with the application made by the Applicant under section 10 of the City Area Leases Act 1936 unless otherwise stipulated in this Instrument;
- that no person other than the Applicant will conduct or in any way carry on the business on the land without the prior approval of the Minister;
- that the Applicant will ensure that all residence and business related vehicles are parked within the confines of the land and must ensure that there are four (4) visitor car parking spaces to be maintained on site at all times;
- that the Applicant will not employ any more than one assistant for the purpose of conducting or carrying on the business on the land without the prior approval of the Minister;
- 8 that only the approved area in the house be used for the conduct of the business;

- that the Applicant must ensure that there will be no public exhibitions or openings conducted on the land;
- that the business will only be conducted on the land between the hours of 11.00 am to 5.00 pm Saturdays to Sundays;
- 11 that the Applicant will conduct the business strictly by appointment;
- that this approval will terminate on the THIRTY FIRST day of JULY 1994 or on such earlier date as the Minister determines in accordance with condition 13;
- upon any failure to comply with any or all of the foregoing conditions the Minister or his Delegate under the said Act may give written notice requiring the Applicant to show cause within a period of fourteen days why this approval should not be revoked. At the expiration of this period the Minister or his Delegate may revoke the approval.
