CITY AREA LEASES ACT 1936

INSTRUMENT OF APPROVAL UNDER SECTION 10

Under section 10 of the City Area Leases Act 1936 I BARBARA DAWN FORREST APPROVE of HELEN JANETTE PURDAM ("the Applicant") carrying on the profession trade occupation or calling of VETERINARY SURGEON ("the business") on Block 6 Section 11 Division of HALL known as 33 VICTORIA STREET, HALL ("the land") subject to the following conditions relating to the use of the land being observed by the Applicant in carrying on the business -

- 1 that this approval will remain valid only while the Applicant continues to be a bona fide resident of the land;
- 2 that the Applicant will ensure that the conduct of the business does not cause an annoyance a nuisance or danger and is not offensive to any tenants or occupiers of adjoining lands;

- 3 that the Applicant will not erect or permit or suffer to be displayed or erected upon the land or any building thereon any advertising sign or hoarding whatever without the consent in writing of the Australian Capital Territory Planning Authority and the Building Controller;
- 4 that the Applicant will conduct the business strictly in accordance with the application made by the Applicant under section 10 of the City Area Leases Act 1936 unless otherwise stipulated in this Instrument;
- 5 that no person other than the Applicant will conduct or in any way carry on the business on the land without the prior approval of the Minister;
- 6 that the Applicant will ensure that all residence and business related vehicles are parked within the confines of the land;
- 7 that the Applicant will abide by Clinical Waste Act 1990 by disposing of their Clinical Waste in the manner designated by the Clinical Waste Manual;
- 8 that the Applicant will not employ any more than one assistant for the purpose of conducting or carrying on the business on the land without the prior approval of the Minister;
- 9 that only the approved surgery area be used for the conduct of the business;
- 10 that the business will only be conducted on the land between the hours of 8.30 am and 6.00 pm Monday to Friday and 9.00 am and 12.00 noon Saturdays;
- 11 that no animal requiring treatment shall be kept on the premises over night;
- 12 that no goods shall be sold from the premises unless such goods are related directly to the veterinary practice;
- 13 that the Applicant will comply with all Health Regulations in relation to veterinary surgeries;
- 14 that the Applicant will allow the Health Surveyors to enter and inspect the premises at any reasonable hour during the day or night;

- 15 the provision is made for the safe disposal of clinical wastes, dead animals and body parts;
- 16 that the Applicant will conduct the business strictly by appointment, and that such appointments will be organised to ensure that no more than three patients are in attendance at any one time;
- 17 that this approval will terminate on the TWENTY EIGHTH day of FEBRUARY 1994 or on such earlier date as the Minister determines in accordance with condition 18;
- 18 upon any failure to comply with any or all of the foregoing conditions the Minister or his Delegate under the said Act may give written notice requiring the Applicant to show cause within a period of fourteen days why this approval should not be revoked. At the expiration of this period the Minister or his Delegate may revoke the approval.
