**MILK AUTHORITY ACT 1971**

The Milk Authority of the Australian Capital Territory, in pursuance of Section 16A of the Milk Authority Act 1971, hereby fixes and declares:

1. This notice takes effect on Friday 1 July 1994.
2. All Gazette notices published prior to the date of this notice pursuant to Section 16A of the Milk Authority Act 1971 are hereby revoked.
3. Pursuant to Section 16A(1) of the Milk Authority Act 1971:
  - (a) The maximum price at which packaged milk (pasteurised or pasteurised and homogenised, including modified milk and flavoured milk as specified) may be sold by retail is fixed at and declared to be:
