LAND (PLANNING AND ENVIRONMENT) ACT 1991

AUTHORISATION

Under subsection 283 of the Land (Planning and Environment) Act 1991 I

1. **REVOKE** all previous authorisations of my powers under the provisions specified in Column 2 of the Schedule insofar as they relate to any of the offices specified in Column 1 of the Schedule; and
2. **AUTHORISE** the person for the time being holding or performing the duties of an office specified in Column 1 of the Schedule, my powers under the provisions specified in Column 2 of the Schedule, opposite and in relation to that office.

In this instrument, a reference to a position number is a reference to an office created under the Public Service Act 1922 of the Commonwealth which is located in the branch of the Australian Public Service comprising the Transitional Staff as that term is defined in the ACT Self-Government (Consequential Provisions) Act 1988 of the Commonwealth.
