- 3 Service and academic or other qualifications relevant to the rank of Firefighter Third Class, recognised by the Commissioner as equivalent to those detailed in 1 or 2

Firefighter - Second Class

- 1 One year of satisfactory service at the rank of Firefighter Third Class and have passed the qualifying examination for promotion to the rank of Firefighter Second Class, or
- 2 One year of satisfactory service at the rank of Firefighter Third Class and have successfully completed all training modules or programs² required for promotion to the rank of Firefighter - Second Class, or
- 3 Service and academic or other qualifications relevant to the rank of Firefighter Second Class, recognised by the Commissioner as equivalent to those detailed in 1 or 2

Firefighter - First Class B grade

- 1 One year of satisfactory service at the rank of Firefighter Second Class and have passed the qualifying examination for promotion to the rank of Firefighter First Class B grade, or
- 2 One year of satisfactory service at the rank of Firefighter Second Class and have successfully completed all training modules or programs² required for promotion to the rank of Firefighter First Class B grade, or
- 3 Service and academic or other qualifications relevant to the rank of Firefighter First Class B grade, recognised by the Commissioner as equivalent to those detailed in 1 or 2

Senior Firefighter

- 1 One year of satisfactory service at the rank of Firefighter First Class A grade and have passed the qualifying examination for promotion to the rank of Senior Firefighter, or
- 2 One year of satisfactory service at the rank of Firefighter First Class A grade and have successfully completed all training modules or programs² required for promotion to the rank of Senior Firefighter, or
- 3 Service and academic or other qualifications relevant to the rank of Senior Firefighter, recognised by the Commissioner as equivalent to those detailed in 1 or 2
- 4 Alternatively, have five years satisfactory service as a Firefighter First Class A grade

Station Officer³

- 1. Two years satisfactory service at the rank of Senior Firefighter and have passed the qualifying examinations for promotion to Senior Firefighter and Station Officer, or
- 2 Two years satisfactory service at the rank of Senior Firefighter and have successfully completed all training modules or programs² required for promotion to the ranks of Senior Firefighter and Station Officer.
- 3. Service and academic or other qualifications relevant to the rank of Station Officer, recognised by the Commissioner as equivalent to those detailed in 1 or 2

ACADEMIC OR OTHER QUALIFICATIONS THAT ARE RELEVANT FOR PROMOTION WITHIN THE ACT FIRE BRIGADE

District Officer³

- 1 Two years satisfactory service at the rank of Station Officer and have passed the qualifying examination for the rank of District Officer, or
- 2 Two years satisfactory service at the rank of Station Officer and have successfully completed all training modules or programs² required for promotion to the rank of District Officer
- 3 Service and academic or other qualifications relevant to the rank of District Officer, recognised by the Commissioner as equivalent to those detailed in 1 or 2

Superintendent³

- 1 Have successfully completed all training modules or programs² required for promotion to the rank of Superintendent
- 2 Service and academic or other qualifications relevant to the rank of Superintendent, recognised by the Commissioner as equivalent to those detailed in 1
