Section 19D - Statement of Reasons for Amendment

This statement outlines the reasons for the amendment of performance criteria under section 19D of the *Financial Management Act 1996*.

Housing ACT in the Department of Disability, Housing and Community Services is amending the performance criteria in Output 1.2: Community and Supported Housing (in Output Class1: Housing Services) by deleting the following duplicate measures included in the Performance Measures reported in the Budget by error:

1. Customer satisfaction of community housing tenants maintained to at least National average with a Target of > 77% in 2003-04.

This measure was replaced by the Quality/Effectiveness Measure – Funded organisation’s satisfaction with government contract administration (as measured by annual survey) with a Target in 2003-04 of 80%.

2. Payments made by the department within 28 days of receipt of account from agencies administering concessions or benefits with a Target of 90% in 2003-04.

This measure was replaced by the Timeliness Measure – Contract payments disbursed within contracted timeframes, with a Target in 2003-04 of 95%
