## **1 Name of instrument**

This instrument is the Tree Protection (Authorised People) Appointment 2008 (No 1).

## **2 Commencement**

This instrument commences on the day after its notification day.

## **3 Appointment of authorised people**

I appoint the people who from time to time occupy the public service positions listed in column 2 of the schedule as authorised people.

*Note 1* The *Legislation Act 2001* defines 'occupy', in relation to a position, to include hold the position, act in the position or exercise functions of the position.

*Note 2* Section 85 of the *Tree Protection Act 2005* requires authorised people to be public servants. The *Legislation Act 2001* defines 'public servant' to mean a person employed in the Australian Capital Territory Public Service.
