# Building (General) (Asbestos Handling Occupation and Qualification) Declaration 2009 (No 1)

Building (General) Regulation 2008, section 48

## 1 Asbestos handling occupation—regulation s 48 (1)

- (1) Under the *Building (General) Regulation 2008*, section 48 (1), I declare each of the following occupations for that regulation, schedule 1, part 1.3, item 25 (which is about handling small amounts of bonded asbestos)—
  - (a) an occupation listed in the attached schedule, in so far as the occupation relates to providing adjustment, addition, alteration, construction, demolition, enhancement, maintenance, removal, renovation, repair, or upgrading services in respect of any part of a building's structure, fabric, integral fixtures, mechanical services, fire services, access services, egress services, electrical services or piped services; or
  - (b) an occupation at the level of apprentice, assistant, associate, cadet, co-worker, instructor, labourer, leader, manager, superintendent, supervisor, trainee, trainer, or understudy in an occupation under paragraph (a); or
  - (c) an occupation however described that involves doing or assisting with the *primary tasks* of any of the occupations under paragraph (a) or (b), on a permanent, temporary or incidental basis.

#### (2) In this section—

*primary tasks* means the tasks listed as 'primary tasks' of the relevant the *Australian and New Zealand Standard Classification of Occupations* ("ANZSCO"), first edition, 2006 published by the Australian Bureau of Statistics and available at www.abs.gov.au.

### 2 Asbestos qualification—regulation s 48 (2)

- (1) Under the *Building (General) Regulation 2008*, section 48 (2), I declare the qualification gained from successful completion of any 1 of the following courses for that regulation, schedule 1, part 1.3, item 25 (which is about handling small amounts of bonded asbestos)—
  - (a) the *Course in Identification and Safe Handling of Asbestos* with national accreditation number '80803ACT'; or
  - (b) the *Course in Asbestos Removal and Supervision* with the national accreditation number '80804ACT'; or
  - (c) any course that would entitle a person to supervise or remove bonded asbestos under a licence or registration in an Australian jurisdiction.

#### 3 Commencement

This instrument commences on the day after notification.

#### 4. Revocation

This instrument revokes notifiable instrument NI2008-117 dated 24 April 2008 and notified under the Legislation Register on 1 May 2008.
