Purpose

To outline the policy for the provision of meals for prisoners.

Authority

Legislation

Corrections Management Act 2007, sections 14 and 40.

Policy

Principles

Prisoners are entitled to be provided with sufficient food and drink to avoid hunger and poor nourishment. These meals will be served at times consistent with the cultural norms of Australia.

Prisoners may apply to be provided with a special diet (including for religious, cultural, and spiritual reasons).

Requests for special diets must be made in writing to the Superintendent through the Deputy Superintendent.

Meal Preparation

Prisoners in Cellblocks, the Management Unit, the Remand Cottage, the Female High Needs Cottage and the Crisis Support Unit will be issued with a meal prepared in the kitchen.

Sentenced prisoners in cottages will normally cook their own meals.

Meal delivery and service

Prisoners and catering staff working in the kitchen will deliver food to the Cellblocks, Management Unit, Remand Cottage, Female High Needs Cottage and Crisis Support Unit. Prisoners will be provided with a breakfast pack in the evening.

Cottage prisoners

Prisoners in sentenced cottages will be allocated a budget that can be used to order items from an approved list. These items will be delivered to the cottages on a weekly basis. Staff from Food Services will provide cottage prisoners with the required training and assistance to cook nutritious meals. Food Services staff will audit meals prepared by cottage prisoners to ensure they are receiving appropriate nutrition.

Special diets

Vegetarian

Prisoners may select a vegetarian option from the Menu Order Sheet.

Prisoners who wish to receive a vegan meal may apply for this by submitting a Prisoner Request Form to the Superintendent through the Deputy Superintendent.

Religious

Prisoners who wish to receive a diet consistent with a particular religion (for example Halal or Kosher foods) may apply for this by submitting a Prisoner Request Form to the Superintendent through the Deputy Superintendent. The Deputy Superintendent may seek advice from the Chaplain or any other person to assist them in making a recommendation to the Superintendent.

Medical

Corrections Health staff may request that a prisoner be placed on a particular diet. This request will be made in writing to the Superintendent through the Deputy Superintendent and will detail the reasons for the request.

Prisoners with food allergies should contact Corrections Health staff who may assess the allergy and recommend a special diet if necessary.

Approval

The discretion to grant or deny a special diet rests with the Superintendent.

If the Superintendent approves a prisoner's application to receive a special diet, the Superintendent will advise the Catering Services Manager who will take responsibility for providing the diet.

The CO2 of the prisoner's accommodation area will document the decision by making a case note in JOIST.

Discontinuation

Prisoners wishing to discontinue a special diet will submit a Prisoner Request Form detailing the reasons for the discontinuation to the Superintendent through the Deputy Superintendent.
