1 Name of instrument

This instrument is the Domestic Animals (Registrar, Deputy Registrars and Authorised Officers) Appointment 2011 (No 1).

2 Commencement

This instrument commences on the day after its notification day.

3 Appointment of registrar

I appoint the person who from time to time occupies the position listed in column 2 of table 1 of the schedule as the registrar.

4 Appointment of deputy registrars

I appoint each person who, from time to time occupies a position listed in column 2 of table 2 of the schedule as a deputy registrar.

5 Appointment of authorised officers

I appoint each person who, from time to time occupies a position listed in column 2 of table 3 of the schedule as an authorised officer.

Note The Legislation Act 2001 defines 'occupy', in relation to a position, to include hold the position, act in the position or exercise functions of the position.

6 References to positions

In this instrument, a reference to a position is a reference to a position in the public service.
