This instrument is the Road Transport (Public Passenger Services) Information to be Displayed in Taxis Approval 2012 (No 1).

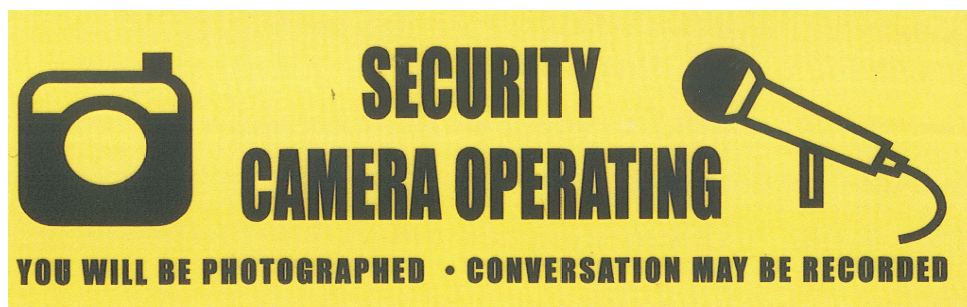
2. Commencement

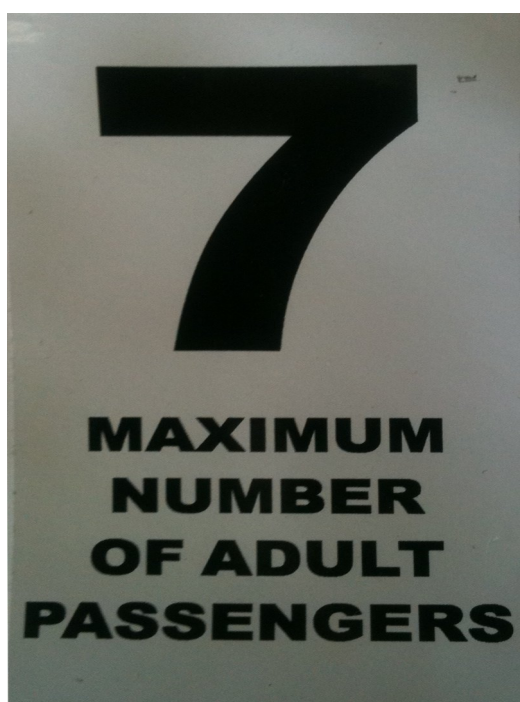
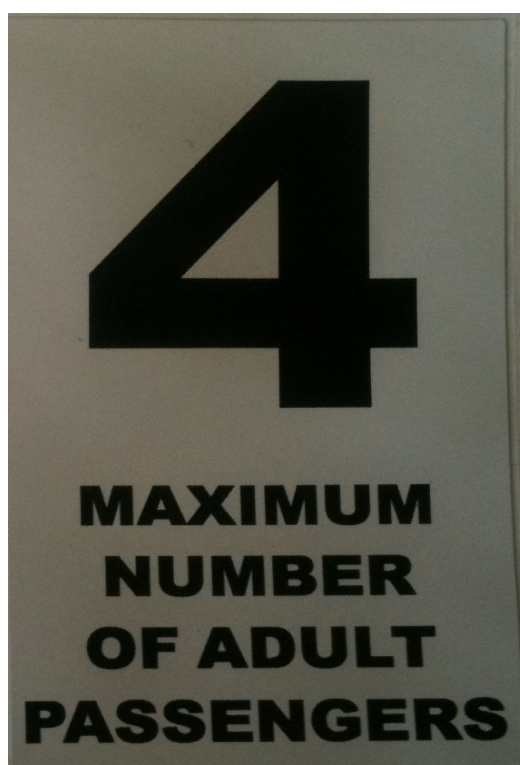
