## 1 Name of instrument

This instrument is the Tree Protection Delegation 2012 (No 1).

## 2 Commencement

This instrument commences on the day after it is signed.

## 3 Delegation of powers

I delegate to the people from time to time occupying the public service positions specified in column 1 of the schedule, my powers under the provisions of the *Tree Protection Act 2005* specified in column 3 of the schedule.

*Note* The Legislation Act 2001 defines 'occupy' in relation to a position to include hold the position, act in the position or exercise the functions of the position.

## 5 Revocation of former instruments

This instrument revokes all previous delegations made under the *Tree Protection Act 2005*.
