Crimes Act 1900, section 154 (Additional offences on territory premises)

1 Name of instrument

This instrument is the *Crimes (Territory and Municipal Services) Authorisation 2013*.

2 Commencement

This instrument commences on the day it is signed.

3 Authorisation

- (1) I authorise those officers employed with the Territory and Municipal Services Directorate named in the schedule to direct a person in or on directorate premises to leave those premises.
- (2) In this authorisation, ***directorate premises*** means any land, building or part of a building occupied by the Territory and Municipal Services Directorate.

Note Failure to comply with a direction of an authorised person is an offence under section 154(2)(c) of the *Crimes Act 1900*.

4 Revocation

This instrument revokes all previous authorisations made in relation to Territory and Municipal Services Directorate premises for the purposes of section 154(2)(c) of the *Crimes Act 1900*.
